ASSOCIATE STUDENT - Enrolled full time in an undergraduate college or university program. Pursuing education intended to lead to a career in a commercial real estate field (At CREW-Baltimore's discretion).

CIVIC - Involved in local or regional government, other public agencies, universities or other educational institutions or not-for-profit organizations (At CREW-Baltimore's discretion).

RETIRED– Must have been a member of CREW for at least four (4) years prior to retirement from employment; was employed in the commercial real estate industry for at least five (5) years prior to retirement.

Membership Qualification:

Prospective applicants must attend one (1) open meeting within a twelve-month period, be sponsored by a CREW-Baltimore member, and be approved by the CREW-Baltimore Board of Directors.
